Since the entry of the order, the JPML 28

has set a hearing on the Motion to Transfer for May 28, 2015. On April 4, the clerk issued a notice setting a Case Management Conference for June 4, 2015, and setting the deadline for CMC Statements on May 28, 2015. Because the JPML will not hear the motion until May 28, the Motion to Transfer will likely not be resolved as of the June 4, CMC date. If the motion is granted, it will moot the need for further proceedings in this Court. If the motion is denied, Defendants' time to respond to the Complaint will likely not expire until some time in July 2015. In light of the foregoing the undersigned parties stipulate and request that the Court vacate the Case Management Conference currently set for June 4, 2015 in pending Motion to Transfer.
