Sub: Notice and Demand for Disclosure of Information About Blocking of Facebook Page in India

Dear General Counsel:

I am legal representative to Sikhs For Justice (SFJ), a human rights advocacy group. SFJ maintains a facebook page <https://www.facebook.com/SikhsForJusticePage>

It has come to our knowledge that SFJ's facebook page has been blocked in India and cannot be accessed by internet users in India.

SFJ is a registered human rights group and only undertakes legally protected democratic and political activities and promotes human rights as guaranteed by US laws and Universal Declaration of Human Rights.

We have not been informed, notified and given an opportunity to counter the reasons for "blocking" of our facebook page.

I am writing to demand that facebook:

1. "unblock" sfj's facebook page in India and make it available to internet users in India as it used to be.
2. provide us in details the reasons for blocking of SFJ page in India.
3. any communication, oral, written or electronic with anyone including local or foreign government authorities relating to blocking of SFJ's facebook page in India.

If Facebook Inc. failed to respond to SFJ's demand for disclosing of the above within 5 business days, SFJ reserves the right to file a lawsuit. This correspondence will serve as notice to the Facebook Inc. of SFJ's intent to file a lawsuit related to this matter.
