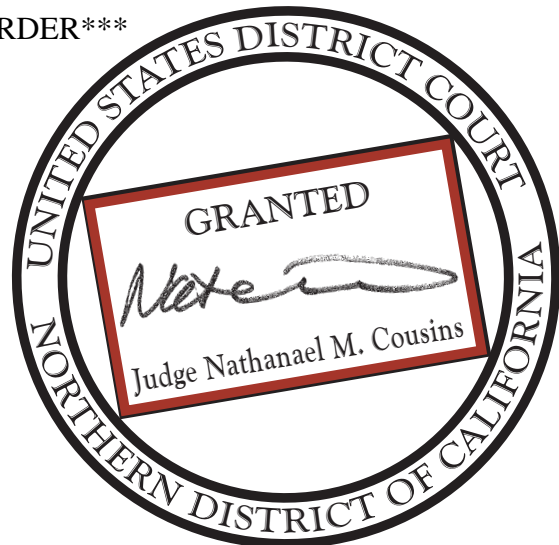
**ORDER CONTINUING INITIAL CASE
