 21 Civil L.R. 7-11 and 79-5 regarding the filing under seal of Exhibits A and B to the Declaration of M.
 22 Monica Ip ("Exhibits"), filed in support of her Opposition to Domtar Corporation's Motion for

4 that Domtar [~~HAS~~ / ~~HAS NOT~~] established that the Exhibits are sealable.]

5 After considering the foregoing, IT IS HEREBY ORDERED that the Administrative Motion is
6 [GRANTED / DENIED]. Plaintiff is directed to take all necessary action, if any, to file the Exhibits
7 with the Clerk of Court in conformance with this Order.
