1 Pursuant to the Northern District of California’s Local Rules 7-11 and 79-5, on July 18, 2017,
2 Greenberg Traurig, LLP (“GT”) filed its Administrative Motion to file under seal portions of GT’s
3 Opposition to Motion for Mandatory Disqualification of Greenberg Traurig LLP, William J. Goines, and
4 Cindy Hamilton, Counsel of Record for Gregory Ahn and Cult Of 8, Inc. (the “Opposition”).
