1 **STIPULATION EXTENDING TIME FOR**  
2 **PARTIES TO PRIVATELY MEDIATE**

3 On August 23, 2017, Defendant GlaxoSmithKline (“GSK”) and Plaintiffs Laura Gray  
4 and Alyssa Gray selected private mediation before Ellen K. Reisman of Reisman Karron  
5 Greene, LLP as the parties’ form of alternative dispute resolution (“ADR”). The parties agreed  
6 to hold the ADR session by December 8, 2017.

7 That selection and date were entered as an order by this Court on August 24, 2017.

8 The parties have met and conferred, and based on the current state of case development,  
9 including a request from Plaintiffs to extend the time to respond to GSK’s Discovery requests,  
10 both parties believe that additional time to conduct discovery is necessary before holding a  
11 private mediation .

12 THEREFORE, the parties hereby stipulate to extend the date by which private mediation  
13 must be held from December 8, 2017 to February 28, 2018. This extension will not affect the  
14 other dates currently scheduled by the Court.
