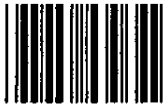

21 1. On July 7, 2005, this Court signed an Order Granting Defendants' Motion to Compel a  
22 More Definite Statement, pursuant to Federal Rule of Civil Procedure 12(e), of Plaintiffs Copyright  
23 Infringement claim. The Order was filed on July 12, 2005.

24 2. The Court ordered Plaintiffs to file an Amended Complaint addressing the Court's


