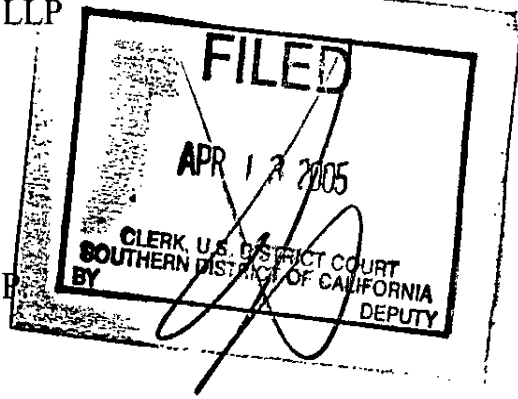


26 2. I am an attorney in good standing of the Bars of State of New York, admitted






