21		to Interrogatories"). Plaintiff may use this evidence for impeachment purposes;
22	•	GRANTS Defendants' objections to Plaintiff's Exhibit 38 ("Rules Violation
23		Report"). Parties have stipulated that plaintiff's conviction was overturned, and
24		Plaintiff indicates that he will not need this Exhibit.
25	•	DENIES Defendants' objections to Plaintiff's Exhibit 39 ("Medical Report by Lai");
26	•	GRANTS Defendants' objections to Plaintiff's Exhibit 40 (Affidavit by C. Trott'') on
27		the grounds of hearsay;
