1 I, Thomas Slattery, declare:

2 1. I am one of the supervising attorneys of Pacific Law Center, a professional law  
3 corporation.

4 **Pacific Law Center.**

5 2. Pacific Law Center is registered with the state bar of California; Robert Arentz  
6 is the supervising attorney.

7 3. Pacific Law Center has more than 20 licensed attorneys at its three San Diego  
8 offices—La Jolla, Escondido and Chula Vista. Overall, Pacific Law Center has more than 100  
9 employees.

10 4. During the last four years in San Diego, Pacific Law Center spends millions of  
11 dollars in print and other media advertising.

12 5. The sole purpose of that advertising is to associate Pacific Law Center with  
13 high quality legal services for our clients in the three areas in which Pacific Law Center  
14 attorneys primarily practice: personal injury, criminal and consumer bankruptcy  
15 representation.

16 6. Over the course of time, and because of that advertising, consumers of legal  
17 services identify Pacific Law Center with the professional corporation that is registered with  
18 the State Bar of California and which provides high quality legal services for clients  
19 throughout San Diego county.

20 7. Pacific Law Center owns the website pacificlawcenter.com. That website is a  
21 major avenue for clients to learn about Pacific Law Center, its attorneys and the services it  
22 provides. It also provides a way for clients to reach Pacific Law Center.

23 8. As a result, the trade name and service mark, "Pacific Law Center" has  
24 achieved a secondary meaning in the minds of the consuming public as a specific source of  
25 high quality legal services for clients in San Diego county.

26 **Mr. Saadatnejad's Conduct.**

27 9. Since Mr. Saadatnejad began his campaign using pacificlawcenters.com  
28 [emphasis added] there is confusion among consumers of legal services whether his website

1 is official website of Pacific Law Center.

2 10. Pacific Law Center has had clients and potential clients call and inquire  
3 whether Pacific Law Center admits to engaging in the kind of conduct that Mr. Saadatnejad  
4 accuses it on his pacificlawcenters.com website.

5 11. Pacific Law Center has had clients and potential clients tell us that they will  
6 not retain Pacific Law Center as a result of what they see on pacificlawcenters.com and  
7 what they apparently believe are admissions of Pacific Law Center, the professional  
8 corporation.

9 12. Mr. Saadatnejad has made clear that he will not stop using the Pacific Law  
10 Center mark and trade name unless this Court enters an injunction that forces him to do so.

11 13. Indeed, Mr. Saadatnejad has told Pacific Law Center that he intended to use  
12 pacificlawcenters.com to create precisely the kind of confusion in the minds of the  
13 consuming public that has in fact occurred.

14 14. Mr. Saadatnejad has told Pacific Law Center that, unless it pays him \$500,000,  
15 he will continue to use the confusingly similar pacificlawcenters.com website and continue  
16 to say the things that he has said about Pacific Law Center and its attorneys and employees.

17 15. I attach true and correct copies of some of the postings on  
18 pacificlawcenters.com's website as Exhibit 1.

19 16. I attach as Exhibit 2 a true and correct copy of the Pacific Law Center website.

20 17. In those postings, Mr. Saadatnejad accuses Pacific Law Center of lying to and  
21 cheating its clients. He calls Pacific Law Center attorneys "thieves," "liars," "scam artists,"  
22 "hustlers." He also associates Pacific Law Center with methamphetamine laboratories and  
23 child abuse and child slavery.

24 18. He makes it look as if the official website of Pacific Law Center has been  
25 "hacked."

26 19. He claims that Pacific Law Center "robbed," him although all of his retainer  
27 both unearned and earned was returned in full.

28 20. Mr. Saadatnejad also defames Phillips & Associates, an Arizona professional

1 corporation that is related to Pacific Law Center.

2 Mr. Saadatnejad is a Former Client of Pacific Law Center.

3 21. Pacific Law Center was retained by Mr. Saadatnejad's mother to represent him  
4 in a criminal case in San Diego in which he was charged generally with driving under the  
5 influence, being drunk in public, fighting in public, disorderly conduct and vandalism.

6 22. The details of Pacific Law Center's representation of him are in Matthew  
7 Spiegel's declaration.

8 23. Pacific Law Center has refunded to Mr. Saadatnejad not only unused portions  
9 of his retainer but, in fact, the whole of that retainer.

10 24. The statements about Pacific Law Center and its attorneys and employees are  
11 obviously false and are causing Pacific Law Center damage.

12 25. Pacific Law Center has already suffered irreparable harm as a result of  
13 Saadatnejad's conduct and it will continue to suffer irreparable harm unless this Court stops  
14 him.

15 26. There is no way accurately to determine the whole of the harm that Mr.  
16 Saadatnejad has done to Pacific Law Center and its reputation and the reputation of its  
17 attorneys. As a result, money damages are inadequate to repair that harm. In that respect,  
18 Pacific Law Center has suffered and continues to suffer irreparable harm and will do so until  
19 this Court stops Mr. Saadatnejad.

20 I declare under penalty of perjury under the laws of the State of California that the  
21 facts in this declaration are true and correct of my own personal knowledge, or based on  
22 information that I believe to be true, and that I executed it on February 26, 2007 at San  
23 Diego, California.

Driving under the influence of alcohol, drunk driving, drinking and driving, or drink-driving, is the act of operating a motor vehicle (and sometimes a bicycle or similar human-powered vehicle) after having consumed alcohol (ethanol) or other drugs, to the degree that mental and motor skills are impaired. In addition to driving under the influence of alcohol and driving under the influence of other drugs, a third "DUI" offense consists of driving under the combined influence of alcohol and other drugs. The drugs causing or contributing to the impairment need not be illegal, but can consist of lawfully prescribed or over-the-counter medication. Anti-drunk-driving advertising campaigns have aimed to raise awareness of the legal situation and the dangers of driving while intoxicated. Drunk-driving is responsible for a large number of deaths, injuries, damage and

accidents every year.

The specific criminal offense may be called, depending on the jurisdiction, driving while intoxicated (DWI), driving while impaired (also DWI), operating while intoxicated (OWI), operating a motor vehicle while intoxicated (OMVI), driving under the influence [of alcohol or other drugs] (DUI), driving under the combined influence of alcohol and/or other drugs, driving under the influence per se or drunk in charge [of a vehicle]. Such laws may also apply to boating, piloting aircraft, and even bicycling in some states such as California.

Historically, guilt was established by subjective tests of the driver's impairment, such as difficulty reciting the alphabet or walking a straight line, together with the arresting officer's subjective opinion. Starting with the introduction in Norway in 1936 of the world's first per se law which made it an offense to drive with more than a specified amount of alcohol in the body, objective chemical tests have gradually supplemented the earlier purely judgmental ones.

Today's statutes commonly provide for two separate and distinct criminal offenses. The first is the traditional "drunk driving" offense, consisting of driving under the influence of alcohol and/or drugs. Evidence to support this crime generally comes from the officer's observations (erratic driving, slurred speech, unsteady gait, etc.), performance on field sobriety tests, and a legal (and generally rebuttable) presumption of intoxication from a blood alcohol test result over the legal limit. The second offense is the more recent so-called "per se" offense: rather than focusing on impairment the crime consists entirely of having a given blood alcohol content (BAC) at the time of driving, regardless of the individual's tolerance to alcohol. Both offenses may be charged, and the defendant may be convicted of both; if a blood alcohol test result was not obtained, only the traditional "DUI" offense will be charged.

BAC is most conveniently measured as a simple percent of alcohol in the blood by weight. It does not depend on any units of measurement. In Europe it is usually expressed as milligrams of alcohol per 100 millilitres of blood. However, 100 milliliters of blood weighs essentially the same as 100 milliliters of water, which weighs precisely 100 grams. Thus, for all practical purposes, this is the same as the simple dimensionless BAC measured as a percent. Since 2002 it has been illegal in all 50 US states to drive with a BAC that is 0.08% or higher.

Driving while consuming alcohol is generally illegal, though driving after drinking remains legal. In some jurisdictions it is also illegal for an open container of an alcoholic beverage to be in the passenger compartment of a motor vehicle or in some specific area of that compartment.

All 50 states now have two statutory offenses. The first is the traditional offense, variously called driving under the influence of alcohol (DUI), driving while intoxicated/impaired (DWI) or operating while intoxicated/impaired (OWI). The second and more recent is the so-called illegal per se offense of driving with a blood-alcohol concentration (BAC) of 0.08% or higher (previously and traditionally a 0.1% or above). The first offense requires proof of intoxication, although evidence of BAC is admissible as rebuttably presumptive evidence of that intoxication; the second requires only proof of BAC at the time of being in physical control of a motor vehicle. An accused may be convicted of both offenses, but may only be punished for one.

It is also a criminal offense in all states to drive a vehicle while under the influence of drugs (DUID), or under the combined influence of alcohol and drugs; the drugs themselves need not be illegal, but can be prescription or even over-the-counter. This offense requires evidence of impairment as a result of the drugs or drugs and alcohol, although some states have passed laws making driving with the mere presence of certain drugs a criminal offense.

Some states also include a lesser charge of driving with a BAC of 0.05%; other states limit this offense to drivers under the age of 21. In all states, it is a criminal offense for drivers under the age of 21 to drive with a BAC of .01% (in some states, .02%).

The blood-alcohol limit for aircraft pilots is 0.04%, and for commercial drivers 0.04% or 0.05%, depending upon the jurisdiction.

The various versions of "driving under the influence" generally constitute a misdemeanor (punishable by up to one year in jail). However, the offense may be elevated to a felony (punishable by a longer term in state prison) if the incident caused serious injury (felony DUI), death (vehicular manslaughter or vehicular homicide), extensive property damage (a state specified dollar amount) or if the defendant has a designated number of prior DUI convictions within a given time period (commonly, 3 prior convictions within 7 years). California, which is being followed by a growing number of states, now charges second-degree murder where the legal state of mind of malice exists -- that is, where the defendant exhibited a grossly

reckless indifference to the lives of others.

A severe punishment for drunk driving is already under way in the state of Ohio for DUI offenders convicted of aggravated vehicular homicide to qualify for capital punishment. The new laws are a result of groups of friends and family of drunk driving victims engaging in active campaigns to get the same justice as victims of other forms of murder. The logic of these laws is that drunk driving is premeditated, and because aggravated vehicular homicide is a felony in both states, the act of killing someone in the commission of such a crime qualifies for a charge of felony murder in the first degree. However, it is unlikely that anyone would be executed due to constitutional issues regarding the Eighth Amendment. This penalty is in addition to the regular DUI and court charges.

Penalties for driving under the influence commonly include incarceration, fines, driver's license suspension or revocation, mandatory attendance at DUI schools, community service, probation and, increasingly, installation of a breath alcohol ignition interlock device.

California leads the nation in DUI arrests. According to the FBI, there were 177,405 California DUI arrests in 2004. Of these almost 1,500 of the DUI arrests were under the age of 18. If you have recently been arrested for driving under the influence in California, we recommend you seek the counsel of a qualified DUI attorney in your local area. Information on the Internet is no substitute for professional legal representation.

People arrested for a California DUI face two separate processes - a California Department of Motor Vehicle (DMV) procedure that determines whether or not the California Drivers License is suspended or restricted, and a court case that can lead to a variety of DUI penalties.

#### California DMV:

In California, a DUI arrest usually results in the officer confiscating the person's California Drivers License and issuing a temporary one. As a matter of course, the California temporary license will expire after 30 days if no action is taken. To prevent loss of driving privileges, the person arrested for DUI can request a CA DMV administrative hearing. The request for a CA DMV administrative hearing must be made within 10 days of DUI arrest.

While you are waiting for your Department of Motor Vehicles administrative hearing, your California Driving privileges will not not be suspended. If you win the administrative hearing, your license will be safe until the court makes a decision. So, by requesting a DMV administrative listing, you will get to keep driving legally longer.

The DMV hearing is an administrative proceeding regarding your driving privilege and the circumstances surrounding the arrest, not whether you are innocent or guilty of a criminal act. The hearing officer - who is an employee of the California Department of Motor Vehicles - makes three determinations: 1) who was driving; 2) if the arresting officer had "reasonable cause" to pull over and arrest the driver; and 3) whether the driver had a blood alcohol concentration of .08 or above. Depending on the DUI case specifics each of these points can be challenged - if you win any one of them, you get to keep your driving privileges. Generally, though, a successful challenge of a California DMV administrative hearing requires the assistance of an experienced DUI attorney.

The California Department of Motor Vehicles maintains 12 Driver Safety Offices. You can only request a DMV administrative hearing, though, at the specific one that handles DUI cases for the county you were arrested in. Find the Driver Safety Office closest to you, but make sure they handle cases from the county of your DUI arrest.

You can find more information at the California DMV's website about DUI administrative hearings.

#### DUI in California Courts:

Chapter 12, Article 2 of the California Vehicle Code covers driving offenses involving alcohol or drugs. Specifically, people arrested for driving under the influence are generally charged under section 23152 - Driving Under Influence of Alcohol or Drugs. The two most common subpoints of 23152 are a and b:

(a) It is unlawful for any person who is under the influence of any alcoholic beverage or drug, or under the combined influence of any alcoholic beverage and drug, to drive a vehicle.

(b) It is unlawful for any person who has 0.08 percent or more, by weight, of alcohol in his or her blood to drive a vehicle.

After being arrested for DUI, defendants are often charged under both the (a) and (b) provisions, may be convicted of both, but can only be punished for one (same DUI penalties anyways). Penalties for a first DUI conviction (unenanced) in California typically include:

3 to 5 years of court probation

A fine, including court fees and costs of \$1400 to \$1800 or more

6 month loss of California Driver License

Forced attendance at DUI School

48 hours of jail time

If there was a prior DUI conviction within 10 years, these penalties go up significantly - California DUI Penalty Chart.

DUI penalties may also be enhanced if there are aggravating factors such as a child in the car (under 14), speeding, driving on a suspended or restricted license, accidents, high blood alcohol content (over .20), etc.

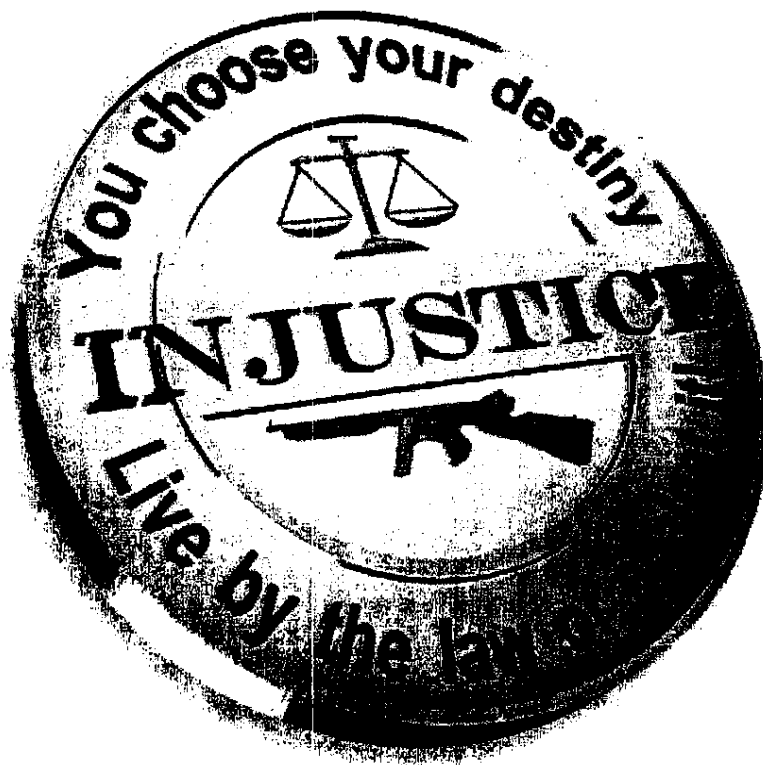

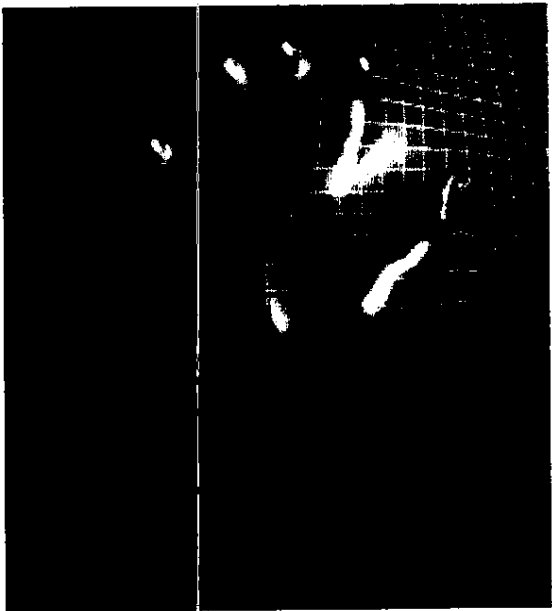
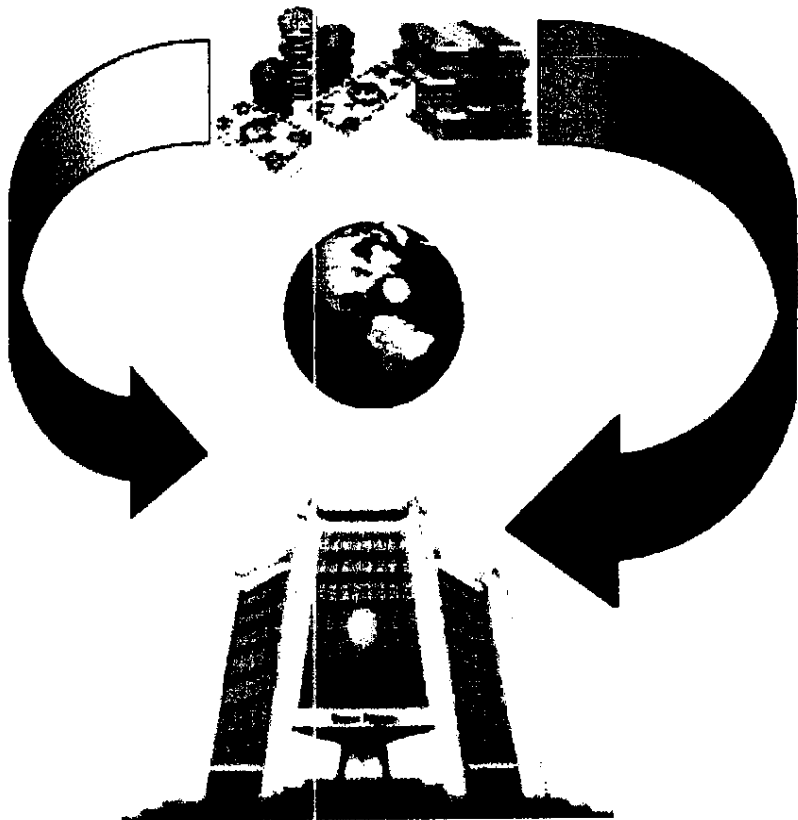

I do not live with my father, which is a fact that Pacific Law Center knows. What lies did Pacific Law Center tell the San Diego Police Department for them to go to my fathers house with Pacific Law Center in a very short notice? San Diego Police Department is very short on officers and it is not fair to say lies about a person(s) in order for the Police to show up, or does Pacific Law Center have a influence on the San Diego Police Department? September 21, 2006 Went and looked at court file - Discovered Pacific Law Center went to court on September 18, 2006 and waived my rights to appear in court and got a continuance - I did a walk in on court calendar 9/21/06 and told Judge Pacific Law Center has committed crimes against me - Took Pacific Law Center off case

November 20, 2006 Pacific Law Center tried to buy me in court

December 15, 2006 Recieved a very disturbing phone call regarding [pacificlawcenters.com](#)

January 26, 2007 Pacific Law Center went to my fathers house in San Diego, California and harassed him and others that were there. Short time later Pacific Law Center [ License Plate No. 5GJM708 ] went back to my fathers house with the San Diego Police Department. I do not live with my father, which is a fact that Pacific Law Center knows. What lies did Pacific Law Center tell the San Diego Police Department for them to go to my fathers house with Pacific Law Center in a very short notice? San Diego Police Department is very short on officers and it is not fair to say lies about a person(s) in order for the Police to show up, or does Pacific Law Center have a influence on the San Diego Police Department? My father has a very bad heart condition, and this kind of harassment with the police may justify a civil complaint from my father against Pacific Law Center.

My fathers wife was so shaken up by Pacific Law Center harrassing her at her home with the San Diego Police Department that she is still shaken up by the whole thing a day later.

January 26, 2007 on or around 6:22pm EST, I called Pacific Law Center and left a message that if they do not drop their civil complaint against me (I just assumed it has to be a civil matter), then I will expose Phillips and Associates on the World Wide Web. On January 29, 2007 I kept checking the internet and it seems that there is no complaint filed against me from Pacific Law Center or they have dropped their complaint if there was one.

Phillips and Associates in Arizona which owns Pacific Law Center in California needs to act professional and pull their lawyers out of court and see if these attorneys need to be disciplined. This is just one of the things that proves that Phillips and Associates is just as dirty as Pacific Law Center. I must inform the general public about Phillips and Associates. The Public has the right to know, plus I would assume that any attorney that sees intentional wrong doings by another attorney, they must report it to the State Bar. I am not a lawyer, but Ethics and Professionalism is mostly common sense.

On September 18, 2006 when Pacific Law Center waived my right to appear in court and then went ahead and represented me after I had fired them, they got a continuance for the case for several days. If I would not have come up with the money to bail out of jail, I would have been still locked up in jail without having the opportunity to tell the judge that Pacific Law Center was fired on September 8, 2006.
