1 Plaintiff JENS ERIK SORENSEN, as Trustee of SORENSEN RESEARCH
2 AND DEVELOPMENT TRUST ("Plaintiff") has moved this Court at Docket # 39
3 for an exception to the stay of proceedings in this case for the purposes of limited
4 discovery.

5 The Court, having considered briefing by the parties and oral arguments on
6 August 20, 2008, **grants in part** and **denies in part** Plaintiff's motion for exception
7 to the stay as set forth below.

8 1. All prototype and production molds used in the production of the
9 accused products within the custody and control of the Defendant(s) are to be
10 preserved.

11 2. All design and technical documents for the accused product within the
12 control and custody of the Defendant(s) are to be preserved.

13 3. Plaintiff is granted leave to propound one (1) interrogatory on the
14 Defendant(s) that asks for the identification of the company names and addresses of
15 nonparty manufacturers, suppliers, and importers who have prototype, production,
16 design, technical documents or evidence regarding the accused products.

17 4. Plaintiff is granted leave to file an Amended Complaint adding accused
18 products within 30 days of this Order. Defendant must respond to said the Amended
19 Complaint within 45 days after the stay is lifted.


