- 9. The Proposed Final Pretrial Conference Order shall be prepared, served and lodged with the Clerk of the Court by *June 14, 2010*.
- 10. The final Pretrial Conference is scheduled on the calendar of Judge Gonzalez on *June 21, 2010* at *10:30 a.m.*.
- 11. All nonconflicting provisions of the court's March 17, 2009 Scheduling Order shall remain in full force and effect.
