24	v. Cook, 169 F.3d 1176, 1177 (9th Cir. 1999).		
25	In this case, Plaintiff has neither prepaid the \$350 filing fee required to commence this		
26	action, nor has he submitted a Motion to Pro	ceed IFP. Therefore, this action is subject to	
20 27	immediate dismissal pursuant to 28 U.S.C. §	1914(a).
