ORDER DISMISSING COMPLAINT  
WITHOUT PREJUDICE

Over the past several years, Plaintiff Grace L. Each action was brought in propria persona and in forma pauperis. Each appears to have been dismissed as frivolous or for failure to state a claim. The present complaint fails


1 no better.

2 Without identifying the basis for the court's subject matter jurisdiction, the complaint sets forth  
3 a rambling narrative of charges and conclusions concerning, for example, theft of money from her  
4 mother, illegal aliens, the murder of orphans, the German race massacre, drug smuggling and other  
5 nefarious acts. As the present complaint, like the scores of previously filed complaints, fails to  
6 identify any basis for federal jurisdiction, or to set forth a coherent statement of her claims, the court  
7 dismisses the complaint at bar as frivolous, for failure to state a claim, and lack of subject matter  
8 jurisdiction.

9 The Clerk of Court is instructed to dismiss the action without prejudice as frivolous and for  
10 failure to state a claim. Until Plaintiff pays the filing fee or demonstrates an imminent danger of  
11 serious physical injury, the Clerk of Court is instructed to reject for filing any further documents from  
12 Plaintiff in this case. The court also denies Plaintiff's motion to proceed in forma pauperis and for  
13 appointment of counsel as moot.
