19	On September 27, 2010, the Court accepted for filing Plaintiff's amended complaint nunc pro		
20	tunc to September 17, 2010. (See Doc. Nos. 47, 48.) Plaintiff filed her amended complaint twenty-		
21	four days after Defendants filed a motion to dismiss Plaintiff's complaint. (Doc. No. 33.) Thus,		
22	Plaintiff did not file her amended complaint within the twenty-one-day time limit for amendment as		
23	of right. Fed. R. Civ. P. 12(a)(1)(B). Plaintiff did not seek leave to amend her complaint. <i>See</i> Fed.		
24	R. Civ. P. 12(a)(2).		
25	The Court construes Plaintiff's untimely amended complaint as a motion for leave to amend		
26	<sup>5</sup> her complaint. <i>See Woods v. Carey</i> , 525 F.3d 886, 889–90 (9th Cir. 2008) ("A document filed pro se		
27	is to be liberally construed, and a pro se complaint, however inartfully pleaded, must be held to less		
28	stringent standards than formal pleadings drafted by lawyers." (internal quotation marks omitted));

1	Popov v. Countrywide Fin. Corp., 2009 WL 5206679, at *2 (E.D. Cal. Dec. 18, 2009) (construing pro	
2	se litigants' opposition, "together with their proposed amended complaint, as a request for leave to	
3	amend their complaint"). Good cause appearing, Plaintiff's motion for leave to amend her complaint	
4	is <b>GRANTED</b> . Plaintiff's amended complaint shall be the operative complaint in this action.	
5	As a result of Plaintiff's amended complaint, the Court DENIES AS MOOT Defendants'	
6	pending motion to dismiss and VACATES the hearing presently set for October 28, 2010.	
7	Defendants' time to respond to Plaintiff's amended complaint shall run from the date the Court's	
8	Order is electronically docketed.
