**ORDER GRANTING JOINT
MOTION FOR PARTIAL STAY AND
CONTINUANCE OF PRE-TRIAL
DATES [Doc. No. 261];**

**THIRD AMENDED SCHEDULING
REGULATING DISCOVERY AND
OTHER PRE-TRIAL
PROCEEDINGS**

On June 9, 2017, the parties filed a Joint Motion for Partial Stay and Continuation of Pre-Trial Dates. [Doc. No. 261.] Therein, they seek to stay until July 24, 2017 the above-captioned action and the three related actions¹ that have been transferred

Petco Animal Supplies, Inc. and Petco Holdings, Inc.*, Civil Action No. 3:17-cv-00898-L-KSC, which was transferred to this Court on May 4, 2017 from the District of Massachusetts; (2) *Michel v. Petco Animal Supplies Stores, Inc. and Petco Holdings, Inc.*, Civil Action No. 3:17-cv-01092-L-KSC, which was transferred to this Court on May 30, 2017 from the Eastern District of New York; and (3) *Hecker v. Petco Animal Supplies, Inc., Petco Animal Supplies*

1 (or are in the process of being transferred) to this Court. [Doc. No. 261, at p. 2.] The reason
2 for the requested partial stay and continuance of certain pre-trial dates is to allow the parties
3 to endeavor to successfully resolve this and the related actions at mediation, which is
4 currently scheduled to proceed on July 20, 2017 with the Hon. Diane M. Welsh (Ret.) of
5 JAMS in Philadelphia. *Id.* The parties assert that the requested partial stay and continuance
6 of certain pre-trial dates will allow them “to focus on the mediation and possible resolution
7 of these actions.” *Id.* The parties further seek to stay decisions on all motions presently
8 before the Court² in the above-captioned action, with notable exceptions as described
9 below. *Id.* at p. 4.

10 The parties request that the following motions are excepted from and not included
11 in the partial stay:

- 13 1. Defendants’ Motion To Dismiss Claims Of Certain Opt-In Plaintiffs With
14 Prejudice For Failure To Respond To Discovery And Comply With Court
15 Orders [Doc. No. 260];
- 16 2. Defendants’ anticipated Motion To Dismiss The Claim Of Farrah Forsythe,
17 pursuant to Federal Rule of Civil Procedure 25; and,
- 18 3. Defendants’ anticipated Motion To Dismiss Claims Of Certain Opt-In
19 Plaintiffs With Prejudice For Failure To Appear At Deposition And Comply
20 With Court Orders, which the parties assert will be filed shortly.

21 [Doc. No. 261.]

22 In addition, the parties jointly request that certain dates³ in the Second Amended

24 *Stores, Inc. and Petco Holdings, Inc. LLC*, which is currently being transferred from the U.S. District
25 Court for the Northern District of Illinois.

1 Scheduling Order Regulating Discovery and Other Pre-trial Proceedings [Doc. No. 184],
2 in the above-captioned action, be continued for 60 days. [Doc. No. 261, at p. 3.] The reason
3 for the parties' request for continuance of certain pre-trial dates is "to enable the parties
4 sufficient time to complete discovery and prepare the necessary pretrial motions should the
5 mediation not be successful." *Id.*

6 Good cause appearing, the Court **GRANTS** the parties' Joint Motion for Partial Stay
7 and Continuance of Pre-Trial Dates. [Doc. No. 261.]

8 (1) The following above-captioned action, *Kellgren v. Petco Animal Supplies, Inc.*
9 *and Petco Holdings, Inc.*, Civil Action No. 3:13-cv-644-L-KSC, is stayed until
10 July 24, 2017.

11 The following actions are also stayed until July 24, 2017:

12 (2) *Cote v. Petco Animal Supplies, Inc. and Petco Holdings, Inc.*, Civil Action No.
13 3:17-cv-00898-L-KSC;⁴

14 (3) *Michel v. Petco Animal Supplies Stores, Inc. and Petco Holdings, Inc.*, Civil
15 Action No. 3:17-cv-01092-L-KSC;⁵ and

16 (4) *Hecker v. Petco Animal Supplies, Inc., Petco Animal Supplies Stores, Inc. and*
17 *Petco Holdings, Inc. LLC*, Case No. 16C10857, which is currently being transferred from
18 the U.S. District Court for the Northern District of Illinois.⁶

1 **IT IS FURTHER ORDERED** that the following motions are excepted from and
2 not included in the partial stay:

- 3 1. Defendants' Motion To Dismiss Claims Of Certain Opt-In Plaintiffs With
4 Prejudice For Failure To Respond To Discovery And Comply With Court
5 Orders [Doc. No. 260];
- 6 2. Defendants' anticipated Motion To Dismiss The Claim Of Farrah Forsythe,
7 pursuant to Federal Rule of Civil Procedure 25; and
- 8 3. Defendants' anticipated Motion To Dismiss Claims Of Certain Opt-In
9 Plaintiffs With Prejudice For Failure To Appear At Deposition And Comply
10 With Court Orders, which the parties assert will be filed shortly.

11 **IT IS FURTHER ORDERED THAT:**

- 12 1. By **September 7, 2017**, each party shall comply with the disclosure
13 provisions in Rule 26(a)(2)(A) and (B) of the Federal Rules of Civil
14 Procedure. This disclosure requirement applies to all persons retained or
15 specially employed to provide expert testimony, or whose duties as an
16 employee of the party regularly involve the giving of expert testimony.
17 **Except as provided in the paragraph below, any party that fails to make**
18 **these disclosures shall not, absent substantial justification, be permitted**
19 **to use evidence or testimony not disclosed at any hearing or at the time**
20 **of trial. In addition, the Court may impose sanctions as permitted by**
21 **Fed. R. Civ. P. 37(c).**
- 22 2. Any party shall supplement its disclosure regarding contradictory or rebuttal
23 evidence under Rule 26(a)(2)(D) by **September 21, 2017**.
- 24 3. All fact discovery shall be completed by all parties by **October 2, 2017**.
25 "Completed" means that all discovery under Rules 30-36 of the Federal Rules
26 of Civil Procedure, and discovery subpoenas under Rule 45, must be initiated
27 a sufficient period of time in advance of the cut-off date, **so that it may be**
28 **completed** by the cut-off date, taking into account the times for service,

1 notice and response as set forth in the Federal Rules of Civil Procedure.
2 **Counsel shall promptly and in good faith meet and confer with regard to**
3 **all discovery disputes in compliance with Local Rule 26.1(a).** The Court
4 expects counsel to make every effort to resolve all disputes without court
5 intervention through the meet and confer process. If the parties reach an
6 impasse on any discovery issue, counsel shall file an appropriate motion
7 within the time limit and procedures outlined in the undersigned magistrate
8 judge's chambers rules. **A failure to comply in this regard will result in a**
9 **waiver of a party's discovery issue. Absent an order of the Court, no**
10 **stipulation continuing or altering this requirement will be recognized by**
11 **the Court.**

- 12 4. All expert discovery shall be completed by all parties by **October 2, 2017.**
13 The parties shall comply with the same procedures set forth in the paragraph
14 governing fact discovery.
- 15 5. All other pretrial motions including those addressing Daubert issues,
16 summary judgment, decertification and final certification of the collective
17 action, but excluding motions *in limine*, must be filed by **November 15, 2017.**
18 Oppositions to the motions are due 30 days after they are filed. Replies shall
19 be due 15 days after the filed Opposition. Counsel for the moving party must
20 obtain a motion hearing date from the law clerk of the judge who will hear
21 the motion. The period of time between the date you request a motion date
22 and the hearing date may vary from one District Judge to another. Please
23 plan accordingly. Failure to make a timely request for a motion date may
24 result in the motion not being heard. The hearing date and briefing schedule
25 for motions *in limine* will be set at the Final Pretrial Conference. Each motion
26 *in limine* shall be accompanied by a certification that the parties met and
27 conferred in an attempt to resolve the issue. Plaintiff shall contact the law
28 clerk of the assigned Magistrate Judge within three court days of receiving a

ruling from the District Court on any of the pre-trial motion.
