Plaintiff has submitted a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. §1915, a Motion for Preliminary Injunction Pursuant to F.R.C.P. Rule 65(a), Title 28 U.S.C.A., a Memorandum of Law In Support of Motion for Preliminary Injunction Against Respondents, and a Prisoner Complaint. The court has determined that the document(s) is/are deficient as described in this order. Notwithstanding the deficiencies, the clerk of the court will be directed to commence a civil action.
