The court has determined that the documents are deficient as described in this order. Notwithstanding the deficiencies, the clerk of the court will be directed to commence a civil action. Plaintiff will be directed to cure the following if he wishes to pursue his claims. Any papers which the Plaintiff files in response to this order must include the civil action number on this order.

ORDERED that the clerk of the court commence a civil action in this matter. It is



action will be dismissed without further notice. The dismissal shall be without prejudice.
