**ORDER DIRECTING CLERK TO COMMENCE CIVIL ACTION AND

Plaintiff has submitted a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. §1915, a Prisoner Complaint, a Plaintiff's Motion for the Appointment of Counsel, and an Affidavit of Jose M. Escobar. The court has

determined that the documents are deficient as described in this order.

Notwithstanding the deficiencies, the clerk of the court will be directed to commence a civil action. Plaintiff will be directed to cure the following if he wishes to pursue his claims.
