**ORDER DIRECTING CLERK TO COMMENCE CIVIL ACTION AND

Petitioner has submitted a Petition Under 28 USC § 2254 for Writ of Habeas Corpus by a Person in State Custody. Petitioner has also tendered the full \$5.00 filing fee. As part of the court's review pursuant to D.C.COLO.LCivR 8.2, the court has determined that the submitted document is deficient as described in this order. Notwithstanding the deficiencies, the clerk of the court will be directed to commence a civil action. Petitioner will be directed to cure the following if he wishes to pursue his claims. Any papers which the Petitioner files in response to this order must include the civil action number on this order.

FURTHER ORDERED that the clerk of the court mail to Petitioner a receipt for the full \$5.00 filing fee. It is

FURTHER ORDERED that, if the Petitioner fails to cure the designated deficiencies **within thirty (30) days from the date of this order,** the petition and the

action will be dismissed without further notice. The dismissal shall be without prejudice.


