ORDER GRANTING SERVICE BY UNITED STATES MARSHAL

If appropriate, the Marshal shall first attempt to obtain a waiver of service of these documents pursuant to Fed. R. Civ. P. 4(d). All costs of service shall be advanced by the United States.


