**ORDER DIRECTING CLERK TO COMMENCE CIVIL ACTION AND

Petitioner has submitted an Affidavit Accompanying Motion of Writ of Habeas Corpus 28 USC 2241 to Proceed In Forma Pauperis, an Application for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241, and an Amendment of Writ of Habeas Corpus 28 USC 2241. FURTHER ORDERED that, if the Petitioner fails to cure the designated deficiencies **within thirty (30) days from the date of this order**, the petition and the action will be dismissed without further notice. The dismissal shall be without prejudice.
