**ORDER DIRECTING CLERK TO COMMENCE CIVIL ACTION AND

As part of the court's review pursuant to D.C.COLO.LCivR 8.2, the court has determined that the submitted documents are deficient as described in this order. Notwithstanding the deficiencies, the clerk of the court will be directed to commence a civil action. Plaintiff will be directed to cure the following if he wishes to pursue his claims. Any papers which the Plaintiff files in response to this order must include the civil action number on this order.

action will be dismissed without further notice. The dismissal shall be without prejudice.
