**ORDER DIRECTING CLERK TO COMMENCE CIVIL ACTION AND  
DIRECTING APPLICANT TO CURE DEFICIENCY**

Applicant has submitted a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 in a Habeas Corpus Action, an Application for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241, an Application for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241(C)(3) and Memorandum of Law In Support of, a Motion for Writ of Habeas Corpus Relief to Dismiss/Discharge Detainer, a Proposed Show Cause Order, a Verification of Statements, a Certificate of Service, and a document titled, "Relief Requested." As part of the court's review pursuant to D.C.COLO.LCivR 8.2, the court has determined that the submitted documents are deficient as described in this order. Notwithstanding the deficiencies, the clerk of the court will be directed to commence a civil action. Applicant will be directed to cure the following if he wishes to pursue his claims. the action will be dismissed without further notice. The dismissal shall be without prejudice.
