MINUTE ORDER

Entered by Michael E. Hegarty, United States Magistrate Judge, on February 28, 2011.

Plaintiff's Motion to Amend the Dispositive Motion Deadline [filed February 21, 2011; docket #163] is granted in part and denied in part. Typically, the press of business itself does not serve as exceptional (or, good) cause for a lengthy extension of time. However, the Court finds the Plaintiff has demonstrated exceptional cause for a moderate extension of time by its continued review of documents recently received from Defendant and its unexpected imposition of work in another case in this district. Therefore, the Court will grant a 30-day extension and amend the Scheduling Order as follows:

Dispositive motions deadline: April 15, 2011

The Court will grant no further extensions of this deadline.

The Final Pretrial Conference scheduled in this case for May 17, 2011 at 9:45 a.m. is hereby **vacated** and **rescheduled** to **June 17, 2011**, at **9:30 a.m.** in Courtroom A501 on the fifth floor of the Alfred A. Arraj United States Courthouse, 901 19th Street, Denver, Colorado.

The parties shall submit their proposed pretrial order, pursuant to District of Colorado Electronic Case Filing ("ECF") Procedures V.L. **no later than five (5) business days** prior to the pretrial conference. The proposed pretrial order to be submitted to the Magistrate Judge under the ECF Procedures <u>must</u> be submitted in a useable format (i.e., WordPerfect or Word only) and shall be emailed to the Magistrate Judge at *Hegarty_Chambers@cod.uscourts.gov*.

Attorneys and/or pro se parties not participating in ECF shall submit their proposed pretrial order on paper to the Clerk's Office. However, if any party in this case is participating in ECF, it is the responsibility of that party to submit the proposed pretrial order pursuant to the District of Colorado ECF Procedures.

The parties shall prepare the proposed pretrial order in accordance with the form

which may be downloaded in richtext format from the forms section of the court's website at <u>www.co.uscourts.gov</u>. Instructions for downloading in richtext format are posted in the forms section of the website.

All out-of-state counsel shall comply with D.C. Colo. LCivR 83.3C prior to the pretrial conference.

The parties are further advised that they shall not <u>assume</u> that the court will grant the relief requested in any motion. Failure to appear at a court-ordered conference or to comply with a court-ordered deadline which has not be vacated by court order may result in the imposition of sanctions.

Please remember that anyone seeking entry into the Alfred A. Arraj United States Courthouse will be required to show a valid photo identification. *See* D.C. Colo. LCivR 83.2B.
