**ORDER DIRECTING CLERK TO COMMENCE CIVIL ACTION AND

Plaintiff has submitted a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 and Prisoner Complaint. As part of the court's review pursuant to D.C.COLO.LCivR 8.2, the court has determined that the submitted documents are deficient as described in this order. Notwithstanding the deficiencies, the clerk of the court will be directed to commence a civil action. Plaintiff will be directed to cure the following if he wishes to pursue his claims. Any papers which the Plaintiff files in response to this order must include the civil action number on this order.

- (13) is missing an original signature by the prisoner

- (17) Sufficient copies to serve each defendant/respondent have not been received by the court.

FURTHER ORDERED that the Plaintiff cure the deficiencies designated above


within thirty (30) days from the date of this order. Any papers which the Plaintiff


