**ORDER DIRECTING CLERK TO COMMENCE CIVIL ACTION AND  
DIRECTING PLAINTIFF TO CURE DEFICIENCY**

Plaintiff, John William Zimmerman, has submitted a document titled "Conditional Acceptance (CAFV) - Request for Proof of Claim as to the Staus [sic] of Monetary Conditions Within the State of Colorado to Pay Debts at Law, Jurisdiction and Other Matters, Constituting Agreement." 
FURTHER ORDERED that the clerk of the court mail to the plaintiff, together with a copy of this order, copies of the following forms to be used in curing the designated deficiencies: Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915; Complaint. It is

FURTHER ORDERED that, if the plaintiff fails to cure the designated deficiencies **within thirty (30) days from the date of this order**, the action will be

dismissed without further notice. The dismissal shall be without prejudice.
