____ Pursuant to F.R.B.P. 8002(c), plaintiff, Jeffrey Hill, Trustee, by his undersigned counsel, hereby seeks a 10-day extension to file Notice of Appeal in the above adversary proceeding.

1. On December 18, 2009, this Court entered its Order Denying the Trustee’s Motion To Amend Findings and Judgment.
2. The Trustee is currently evaluating whether to file an appeal of this Court’s Orders of December 4 and 18, 2009.
3. Absent extension under F.R.B.P. 8002(c), the Trustee’s deadline for filing Notice of Appeal is December 28, 2009.
