**ORDER DIRECTING CLERK TO COMMENCE CIVIL ACTION AND
DIRECTING PLAINTIFF TO CURE DEFICIENCIES**

Plaintiff has submitted a "Motion for Court Order of Account Statement or Waiver of," and a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915. As part of the court's review pursuant to D.C.COLO.LCivR 8.2, the court has determined that the submitted documents are deficient as described in this order.

Notwithstanding the deficiencies, the clerk of the court will be directed to commence a civil action. Plaintiff will be directed to cure the following if he wishes to pursue his claims. Any papers that Plaintiff files in response to this order must include the civil action number on this order.

Plaintiff further is instructed to include a certified copy of his trust fund account statement. To the extent in the Motion for Court Order Plaintiff asserts that he is not able to obtain a certified copy of his account statement, he must submit to the Court a verified statement from his case manager indicating the he refuses to provide to Plaintiff a certified copy of his account statement.

28 U.S.C. § 1915 Motion and Affidavit:

- (3) is missing certified copy of prisoner's trust fund statement for the 6-month period immediately preceding this filing

Accordingly, it is

ORDERED that the clerk of the court commence a civil action in this matter. It is

FURTHER ORDERED that Plaintiff cure the deficiencies designated above **within thirty (30) days from the date of this order**. Any papers which Plaintiff files in response to this order must include the civil action number on this order. It is

FURTHER ORDERED that the clerk of the court mail to Plaintiff, together with a copy of this order, two copies of the following forms: Prisoner Complaint. It is

FURTHER ORDERED that if Plaintiff fails to cure the designated deficiencies **within thirty (30) days from the date of this order** the action will be dismissed without further notice. The dismissal shall be without prejudice. It is

FURTHER ORDERED that Plaintiff's Motion for Court Order of Account Statement or Waiver of submitted on February 23, 2010 is denied.


