FINAL JUDGMENT

Golos Weisman Design, Ltd and Yookidoo, Ltd. are dismissed without prejudice. It is

further

ORDERED that this case is dismissed in its entirety. It is further

ORDERED that the defendant International Playthings, LLC is AWARDED costs,

to be taxed by the Clerk of the Court pursuant to Fed. R. Civ. P. 54(d)(1) and

D.C.COLO.LCivR 54.1.
