DIRECTING PLAINTIFF TO CURE DEFICIENCY**

Plaintiff has submitted a facsimile cover sheet, a Summons, a Civil Cover Sheet, a "Complaint," a document titled "Information for Prelim Injunction Order," a "Plaintiff's Ex Parte Motion and Memorandum of Law for Temporary Restraining Order, Declaratory Relief and Permanent Injunction," a "Declaration for Need to Not Serve Opposition and Reason for Ex Parte Temporary Emergency Orders," a Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 and a one-page untitled statement. ORDERED that the clerk of the court commence a civil action in this matter. It is



FURTHER ORDERED that, if the Plaintiff fails to cure the designated deficiencies **within thirty (30) days from the date of this order**, the complaint and the action will be dismissed without further notice. The dismissal shall be without prejudice.


