ORDER STAYING CASE

This above-entitled matter comes before the Court on Defendants' Unopposed Motion to Enter Order Staying *Ballotti v. OppenheimerFunds, Inc.*, Case No. 11-cv-00602-JLK (doc. #8), filed March 21, 2011.
