Applicant, Russell Cooley, submitted *pro se* a Petition for Writ of Habeas Corpus challenging the computation of his federal sentence imposed in *United States v. Cooley*, No. 05-cr-00059-RBJ-1 (D. Colo. Sept. 22, 2005), and used the docket number for his criminal case on the petition. On April 4, 2012, the clerk of the Court filed the petition (ECF No. 57) in his criminal case. On April 13, 2012, the Court entered an order in No. 05-cr-00059-RBJ-1 directing the clerk of the Court to commence a new civil action and file the petition in that action. ECF No. 58. Pursuant to the April 13 order, the Court opened the instant action.

As part of the Court's review pursuant to D.C.COLO.LCivR 8.2, the Court has determined that the submitted document is deficient as described in this order.

Applicant will be directed to cure the following if he wishes to pursue his claims. Any papers that the Applicant files in response to this order must include the civil action

number on this order.

- (7) \_\_\_ is not on proper form (must use the court's current form)
- (8) \_\_ names in caption do not match names in caption of complaint, petition or habeas application
- (9) X other: Motion is necessary only if \$5.00 filing fee is not paid in advance.

## **Complaint, Petition or Application:**

- (10) is not submitted
- (11) X is not on proper form (must use the court's current form)
- (12) \_\_ is missing an original signature by the prisoner

FURTHER ORDERED that, if the Applicant fails to cure the designated deficiencies within thirty (30) days from the date of this order, the Petition for Writ of Habeas Corpus will be denied and the action dismissed without further notice. The dismissal shall be without prejudice.
