COMES NOW the debtor through counsel and files her Notice of Appeal pursuant to 28 USC § 158. This is an from the *Order granting Plaintiff's Motion for Summary Judgment* (Docket No. 53) entered on the record July 5, 2012. Appellant appeals the following issues:

- 1) This appeal is timely because it is filed within 15 days of the date of entry of the court's order (July 5, 2012).
- The debtor appeals the court's decision denying to her the exemption for the cash value of a certain policy of whole life insurance. The debtor contends that the cash value of her life insurance in 2010 on the date of filing was less than the value of the same in 2006. In other words, the debtor's accumulated cash value declined in value on account of loans taken against the policy. The debtor contends that any or all cash value should have been found to be exempt pursuant to CRS § 13-54-102 (1)(1)(I)(A).
- The history of the policy is that during the 48 months prior to the filing the debtor had contributed monies to the policy and the policy had increased in value. In an attempt to satisfy her creditors and to avoid bankruptcy, the debtor withdrew most of the cash surrender value, leaving an amount at filing that was less than the cash value 48 months prior to the filing. It is therefore the debtor's position that there was no increase in cash value during the preceding 48 months.
- 4) Further, the debtor appeals the court's decision ordering her insurance company to surrender monies which by contract no longer exist. The debtor believes that the court's decision impairs her contract with her insurance carrier.

- Bankruptcy court's opinion, findings of fact, or conclusions of law
- Any other orders relevant to the appeal
- Any motion and response on which the bankruptcy court ruled
- Notice of appeal
