ORDER DIRECTING APPLICANT TO CURE DEFICIENCIES

Applicant will be directed to cure the following if he wishes to pursue any claims in this court in this action. (11) is not on proper form (must use the court's current form)
(12) is missing an original signature by the prisoner
(13) is missing page nos. ____
(14) uses et al. instead of listing all parties in caption
(15) names in caption do not match names in text
(16) addresses must be provided for all defendants/respondents in "Section A. Parties" of complaint, petition or habeas application
(17) other: Application names an improper Respondent; the only proper Respondent is Applicant's custodian.

Accordingly, it is

ORDERED that Applicant cure the deficiencies designated above **within thirty (30) days from the date of this order.** Any papers that Applicant files in response to this order must include the civil action number on this order. It is

FURTHER ORDERED that Applicant shall obtain the court-approved Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 in a Habeas Corpus Action and Application for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241 forms, (with the assistance of his case manager or the facility's legal assistant), along with the applicable instructions, at www.cod.uscourts.gov. It is

FURTHER ORDERED that, if Applicant fails to cure the designated deficiencies **within thirty (30) days from the date of this order**, the action will be dismissed without further notice. The dismissal shall be without prejudice.
