## ORDER DIRECTING PLAINTIFF TO CURE DEFICIENCIES

Plaintiff, Solomon Bowens, currently is incarcerated at the Denver Van Cise-Simonet Detention Center. Plaintiff, acting *pro se*, attempted to initiate this action on January 14, 2013, by filing a motion titled "Motion for Writ of Habeas Corpus," which appears to be a petition for writ of habeas corpus ad testificandum asking to be brought into court to testify about a "medical law suit pending." ECF No. 1 at 1. On January 15, 2013, Mr. Bowens submitted a Prisoner Complaint (ECF No. 3) and a certified copy of his inmate trust fund account statement (ECF No. 4).

As part of the Court's review pursuant to D.C.COLO.LCivR 8.2, the Court has determined that the submitted documents are deficient as described in this order.

Plaintiff will be directed to cure the following if he wishes to pursue his claims. Any papers that Plaintiff files in response to this order must include the civil action number

noted above in the caption of this order.

FURTHER ORDERED that if Plaintiff fails to cure the designated deficiencies within thirty days from the date of this order the action will be dismissed without further notice.
