## ORDER DIRECTING PLAINTIFF TO CURE DEFICIENCIES

Plaintiff, Donald Joseph West, currently is incarcerated at in Amarillo, Texas. He has submitted *pro se* two letters with various attachments to the clerk of the Court (ECF Nos. 1 and 3). He appears to be facing criminal charges in Texas, and fails to make clear the reason or reasons he is attempting to initiate a lawsuit in Colorado.

Mr. West attempts to assert both civil rights claims apparently pursuant to 42 U.S.C. § 1983 challenging his medical treatment and apparently habeas corpus claims pursuant to 28 U.S.C. § 2241 challenging the charges pending against him in Texas.

Mr. West is advised that he may not assert civil rights claims and habeas corpus claims in the same action.

As part of the Court's review pursuant to D.C.COLO.LCivR 8.2, the Court has determined that the submitted documents are deficient as described in this Order.

Plaintiff will be directed to cure the following if he wishes to pursue his claims. Any

papers that Plaintiff files in response to this Order must include the civil action number noted above in the caption of this Order.

FURTHER ORDERED that, if Plaintiff fails to cure the designated deficiencies within thirty days from the date of this Order, the action will be dismissed without further notice.
