ORDER DIRECTING PLAINTIFF TO CURE DEFICIENCIES

It is

FURTHER ORDERED that, if Plaintiff fails to cure the designated deficiencies within thirty (30) days from the date of this order, the Prisoner Complaint and the action will be dismissed without further notice. The dismissal shall be without prejudice. DATED March 29, 2013, at Denver, Colorado.
