Instead, if he wishes to pursue his constitutional claims in this court, he must pursue those claims in a regular civil action. Therefore, the instant civil action has been commenced. As part of the court's review pursuant to D.C.COLO.LCivR 8.2, the court has determined that the documents are deficient as described in this order. Plaintiff will be directed to cure the following if he wishes to pursue his claims. Any papers that Plaintiff files in response to this order must include the civil action number on this order.
