a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915

(with the assistance of his case manager or the facility's legal assistant), along with the

applicable instructions, at <u>www.cod.uscourts.gov</u>, and use that form in curing the

designated deficiencies, if he does not pay the full filing fee in advance. It is

FURTHER ORDERED that, if Plaintiff fails to cure the designated deficiencies

within thirty days from the date of this order, the action will be dismissed without

further notice.
