ORDER DIRECTING PLAINTIFF TO CURE DEFICIENCIES

Plaintiff, a Colorado state prisoner, has submitted to the court a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 and a Prisoner Complaint in which she challenges the computation of her prison sentence. As relief she asks to have 547 days of presentence confinement credit applied to her sentence.

As part of the court's review pursuant to D.C.COLO.LCivR 8.2, the court has determined that the documents are deficient as described in this order. Most importantly, because Plaintiff is challenging the execution of her sentence and seeking habeas corpus relief, her claims properly are asserted in a habeas corpus action pursuant to 28 U.S.C. § 2241. Plaintiff will be directed to cure the following if she wishes to pursue her claim. Any papers that Plaintiff files in response to this order must include the civil action number on this order.

FURTHER ORDERED that, if Plaintiff fails to cure the designated deficiencies within thirty (30) days from the date of this order, the action will be dismissed without further notice. The dismissal shall be without prejudice.
