Applicant will be directed to cure the following if he wishes to pursue any claims in this court in this action. Any papers that Applicant files in response to this order must include the civil action number on this order.

FURTHER ORDERED that Applicant shall obtain the court-approved form for filing a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 in a Habeas Corpus Action (with the assistance of his case manager or the facility's legal assistant), along with the applicable instructions, at <a href="https://www.cod.uscourts.gov">www.cod.uscourts.gov</a>, and use that form in curing the designated deficiencies. Alternatively, Applicant may pay the \$5.00 filing fee in advance. It is

FURTHER ORDERED that, if Applicant fails to cure the designated deficiencies within thirty (30) days from the date of this order, the application will be denied and the action dismissed without further notice. The dismissal shall be without prejudice.
