ORDER DIRECTING APPLICANT TO CURE DEFICIENCIES

Applicant, an inmate at the United States Penitentiary, Administrative Maximum, in Florence, Colorado, has submitted to the court an Emergency Application for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241 (ECF No. 1) challenging his placement in the special housing unit and a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 in a Habeas Corpus Action (ECF No. 3). As part of the court's review pursuant to D.C.COLO.LCivR 8.1(b), the court has determined that the documents are deficient as described in this order. Applicant will be directed to cure the following if he wishes to pursue any claims in this action. Any papers that Applicant files in response to this order must include the civil action number on this order.

28 U.S.C. § 1915 Motion and Affidavit:

- (1) is not submitted
- (2) is missing affidavit
- (3) is missing certified copy of prisoner's trust fund statement for the 6-month period immediately preceding this filing

- (4) is missing certificate showing current balance in prison account
- (5) is missing required financial information
- (6) xx is missing authorization to calculate and disburse filing fee payments
- (7) is missing an original signature by the prisoner
- (8) xx is not on proper form (must use the court's form for civil rights actions)
- (9) names in caption do not match names in caption of complaint, petition or habeas application
- (10) other: _____.

Complaint, Petition or Application:

- (11) is not submitted
- (12) xx is not on proper form (must use the court's Prisoner Complaint form to assert claims challenging conditions of confinement)
- (13) is missing an original signature by the prisoner

- (15) uses et al. instead of listing all parties in caption
- (16) names in caption do not match names in text

Accordingly, it is

ORDERED that Applicant cure the deficiencies designated above **within thirty (30) days from the date of this order**. Any papers that Applicant files in response to this order must include the civil action number on this order. It is

FURTHER ORDERED that Applicant shall obtain the court-approved Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 and Prisoner Complaint forms (with the assistance of his case manager or the facility's legal assistant), along with the applicable instructions, at www.cod.uscourts.gov. It is

FURTHER ORDERED that, if Applicant fails to cure the designated deficiencies **within thirty (30) days from the date of this order**, the action will be dismissed without further notice. The dismissal shall be without prejudice.
