ORDER DIRECTING PLAINTIFF TO CURE DEFICIENCIES

Plaintiff, John Boyd Bowring, is a prisoner in the custody of the Colorado Department of Corrections who currently is incarcerated at the Kit Carson Correctional Center in Burlington, Colorado. He has submitted *pro se* two documents titled "Petition to Pay Debts, Etc." (ECF No. 1) and "First Notice of Default" (ECF No. 3) pursuant to the Debt Collection Improvement Act of 1996, 31 U.S.C. § 3716. Plaintiff fails to make clear whether he intended for these documents to be filed in *Bowring v. Bonner*, No. 13-cv-01707-LTB (D. Colo. Sept. 18, 2013), *affirmed* No. 13-1465 (10th Cir. May 28, 2014), or intended to initiate a new action. *See* ECF No. 1 at 1.

As part of the court's review pursuant to D.C.COLO.LCivR 8.1(b), the court has determined that the submitted documents are deficient as described in this order.

Plaintiff will be directed to cure the following if he wishes to pursue any claims in this court in this action. Any papers that Plaintiff files in response to this order must include

It is

FURTHER ORDERED that, if Plaintiff fails to cure the designated deficiencies within thirty (30) days from the date of this order, the action will be dismissed without further notice. The dismissal shall be without prejudice.
