**ORDER DIRECTING APPLICANT TO CURE DEFICIENCIES**

Applicant, Casey D. Eden, initiated this action by filing *pro se* a Petition for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241 and a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915. As part of the Court's review pursuant to D.C.COLO.LCivR 8.1(b), the Court has determined that the submitted documents are deficient as described in this Order. Applicant will be directed to cure the following if he wishes to pursue his claims. Any papers that Applicant files in response to this Order must include the civil action number on this Order.

**28 U.S.C. § 1915 Motion and Affidavit:**

- (8)  is not on proper form (must use the Court's current form for requesting leave to proceed pursuant to 28 U.S.C. § 1915 in a habeas action)
- (9)  names in caption do not match names in caption of complaint, petition or habeas application
- (10)  An original and a copy have not been received by the court. Only an original has been received.
- (11)  other: In the alternative Applicant may pay the \$5 filing fee.

**Complaint, Petition or Application:**

- (12)  is not submitted
- (13)  is not on proper form (must use a Court-approved form)
- (14)  is missing an original signature by the prisoner
- (15)  is missing page nos. \_\_\_\_
- (16)  uses et al. instead of listing all parties in caption
- (17)  An original and a copy have not been received by the court. Only an original has been received.
- (18)  Sufficient copies to serve each defendant/respondent have not been received by the court.
- (19)  names in caption do not match names in text

Accordingly, it is

ORDERED that Applicant cure the deficiencies designated above **within thirty days from the date of this Order**. Any papers that Applicant files in response to this Order must include the civil action number on this Order. It is

FURTHER ORDERED that Applicant shall obtain the Court-approved form used in filing a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 in a Habeas Corpus Action and an Application for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241 (with the assistance of his case manager or the facility's legal assistant), along with the applicable instructions, at [www.cod.uscourts.gov](http://www.cod.uscourts.gov). It is

FURTHER ORDERED that if Applicant fails to cure the designated deficiencies **within thirty days from the date of this Order** the action will be dismissed without further notice.
