ORDER DIRECTING PLAINTIFF TO CURE DEFICIENCIES

Plaintiff, Jason Edwards, is currently incarcerated at FCI Florence in Florence, Colorado. On August 3, 2015, he filed an Application for a Writ of Habeas Corpus Pursuant to 28 U.S.C. § 2241 (ECF No. 1) and a Prisoner's Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 in a Habeas Corpus Action (ECF No. 2). As part of the Court's review pursuant to D.C.COLO.LCivR 8.1(b), the Court has determined that the § 1915 Motion is deficient as described in this order. Mr. Edwards will be directed to cure the following if he wishes to pursue his claims. Any papers that Plaintiff files in response to this Order must include the civil action number on this Order.

28 U.S.C. § 1915 Motion and Affidavit:

- (1) ___ is not submitted
- (2) ___ is missing affidavit
- (3) ___ is missing certified copy of prisoner's trust fund statement for the 6-month period immediately preceding this filing
- (4) X is missing certificate showing current balance in prison account
- (5) ___ is missing required financial information
- (6) ___ is missing authorization to calculate and disburse filing fee payments

- (7) X is missing an original signature by the prisoner
- (8) — is not on proper form
- (9) — names in caption do not match names in caption of complaint, petition or habeas application
- (10) X other: In the alternative, Applicant may pay the \$5 filing fee.

Complaint, Petition or Application:

- (11) — is not submitted
- (12) — is not on proper form (Applicant may find the Court-approved form used in filing a Civil General Complaint at www.cod.uscourts.gov.)
- (13) — is missing an original signature by the prisoner
- (14) — is missing page nos. —
- (15) — uses et al. instead of listing all parties in caption
- (16) — names in caption do not match names in text
- (17) — addresses must be provided for all defendants/respondents in “Section A. Parties” of complaint, petition or habeas application
- (18) — other:

Accordingly, it is

ORDERED that Plaintiff cure the deficiencies designated above **within thirty days from the date of this Order**. It is

FURTHER ORDERED that Plaintiff shall obtain the Court-approved form used in filing a Prisoner’s Motion and Affidavit for Leave to Proceed Pursuant to 28 U.S.C. § 1915 in a Habeas Corpus Action, along with the applicable instructions, at www.cod.uscourts.gov, and use the form to cure the above noted deficiencies. It is

FURTHER ORDERED that if Plaintiff fails to cure the designated deficiencies **within thirty days from the date of this Order** the action will be dismissed without further notice.
