## ORDER DIRECTING APPLICANT TO CURE DEFICIENCIES

Although it is not clear what type of action Applicant intends to pursue or what claims he intends to assert, the instant civil action has been commenced. As part of the court's review pursuant to D.C.COLO.LCivR 8.1(b), the court has determined that the document is deficient as described in this order. Applicant will be directed to cure the following if he wishes to pursue his claims. If Applicant does not intend to pursue a civil action in this court at this time, he should advise the court of that fact and the instant action will be dismissed. Any papers that Applicant files in response to this order must include the civil action number on this order.
