**ORDER DIRECTING PLAINTIFF TO CURE DEFICIENCY**

Plaintiff Angela Nicole DuCharme currently resides in Rocky Ford, Colorado. On October 27, 2015, she submitted an Application to Proceed in District Court Without Prepaying Fees or Costs, ECF No. 1, and a Civil Cover Sheet, ECF No. 1-1, that states the cause of action is an appeal of a social security decision. As part of the Court's review pursuant to D.C.COLO.LCivR 8.1(a), the Court has determined that the submitted documents are deficient as described in this Order. Plaintiff will be directed to cure the following if she wishes to pursue her claims. Any papers that Plaintiff files in response to this Order must include the civil action number on this Order.

**Application to Proceed in District Court Without Prepaying Fees or Costs:**

- (1)  is not submitted
- (2)  is not on proper form (must use the current Court-approved form)
- (3)  is missing original signature by Plaintiff
- (4)  is missing affidavit
- (5)  affidavit is incomplete
- (6)  affidavit is not properly certified
- (7)  other: In the alternative, Plaintiff may pay the \$400 filing fee.

**Complaint or Petition:**

- (8)   X   is not submitted
- (9)        is not on proper form (must use the court's current form)
- (10)        is missing an original signature by the Plaintiff
- (11)        is incomplete
- (12)        uses et al. instead of listing all parties in caption
- (13)        names in caption do not match names in text of Complaint
- (15)        addresses must be provided for all defendants/respondents in "Section A. Parties" of complaint, petition or habeas application
- (16)        other:

Accordingly, it is

ORDERED that Plaintiff cure the deficiency designated above **within thirty days from the date of this Order**. Any papers that Plaintiff files in response to this Order must include the civil action number on this Order. It is

FURTHER ORDERED that Plaintiff shall obtain the Court-approved form used in filing a civil complaint, along with the applicable instructions, at [www.cod.uscourts.gov](http://www.cod.uscourts.gov), and use the form to cure the above noted deficiency. It is

FURTHER ORDERED that if Plaintiff fails to cure the designated deficiency **within thirty days from the date of this Order** the action will be dismissed without further notice.
