

AFFIDAVIT

JOHN M. REGAN, JR., being duly sworn, deposes and says:

1. I am an attorney admitted in New York since 1989 and in various federal courts.

After a brief period in 1988 and 1989 working as a law clerk for a judge on the New York State Supreme Court in Rochester, I have engaged in the general practice of law concentrating in personal injury work, but have had significant experience in criminal defense as well. I was acquainted with and occasionally represented Gregory Coleman.

2. By way of background, I performed a number of generally small legal tasks for the Coleman family through the 1990's, variously dealing with Jack and Mary Coleman (Gregory's parents) Gregory's sister and her family, and Gregory himself. I was generally aware, primarily through Jack, of Gregory's contentions regarding the Martha Moxley murder and Michael Skakel and the supposed admissions by Michael Skakel to Gregory when they were both attending a drug rehab facility in New England.

3. Gregory was known to his family and me to be an incorrigible drug addict who had served time in prison. During the time I was active in representing the Coleman family, and based in part upon my observations of them, I formed the opinion that Gregory regularly engaged in dishonest, deceitful and criminal behavior in order to obtain money from his father.

4. It would be fair to say that no one in their right mind, knowing Gregory, would put the slightest confidence in his contentions concerning the supposed admissions of Michael Skakel.


5. Sometime in 1998 I received a phone call from a man who identified himself as a prosecutor from Connecticut who was seeking Gregory's contact information from me. I was initially concerned that Gregory had gotten into trouble, so I asked why he was looking for

Gregory. He indicated that he was going to use Gregory in a Grand Jury proceeding seeking to charge Michael Skakel in the infamous Martha Moxley murder.

6. I was incredulous, and commented that I hoped he was not serious that he was going to use Gregory's testimony to accuse someone of murder. He responded by telling me not to worry, that they had plenty of evidence, and that they were going to "get this guy".



I became aware later from news reports that Mr. Skakel had been indicted and convicted, and I was disturbed to see that Gregory's role as a witness had been prominent, at least as far as the news media was concerned, but I continued to assume that there must have been a lot of other solid evidence. I then saw an article by Robert F. Kennedy, Jr. in the Atlantic Monthly which raised a lot of doubt in my mind about my assumption. I made an effort by email to contact him but received no response. Within the last week, more or less on an impulse, I checked the internet for any news on the matter, obtained the name and address of his attorney, Hope Seeley, and contacted her by email so that she could decide whether my limited information would be of any value. She called and asked me for an affidavit on the evening of December 10th.
