The Defendant, on behalf of all parties to the above-captioned matter hereby respectfully submits this proposed Stipulation addressing upcoming deadlines and related matters. The parties respectfully request that the Court “so order” this Stipulation.


The parties hereby agree as follow:

1. The Plaintiffs shall have an extension of time through and including June 25, 2009 by which to file their response to the Defendant’s Motion to Dismiss Robin Sparks as a Plaintiff due to lack of standing.
2. Defendant, based on information received after the filing of the Motion to Dismiss Erin Overdeverst as a Plaintiff due to lack of standing, hereby withdraws such Motion, without prejudice to renew based on other grounds, if applicable.

3. Defendant shall file a responsive pleading to the Complaint within ten (10) days after the Court's ruling on the pending Motion to Dismiss Plaintiff Robin Sparks.
4. The parties shall conduct a discovery conference pursuant to Fed. R. Civ. Proc. 26(f) so as to submit the Report of Parties' Planning Meeting to the Court for its approval by or on June 8, 2009.
5. The parties shall exchange Initial Disclosures also by or on June 8, 2009.


